The Elizabeth Fry Society of Greater Vancouver (EFry) is a charitable organization that supports women, girls, and children at risk, involved in or affected by the justice system. Our programs work to break the cycle of poverty, substance use, mental illness, homelessness, and crime.

We are recruiting for an awake overnight full time, Residential Support Worker for Rosedale Intensive Treatment Program. Located in Chilliwack, the program provides live-in treatment services for women experiencing moderate to severe substance misuse. Women participate in up to 5 months of structured bed based treatment including psychoeducational groups, clinical counselling, and developing as needed relationships with community services to support their longterm needs. Operating on an awake around the clock basis, staff provide participants with individualized case management planning, support with relapse prevention, service navigation and the transition from live-in services back to the community.

KEY RESPONSIBILITIES:

- Support the overall safety and functioning of the substance use treatment program and its residents.
- Manage medication administration in compliance with Policy and Regulations.
- Support clients in attaining their substance use treatment goals, improved community functioning and linkage to community resources and prosocial supports.
- Document all case management activities and client progress.
- Provide life skills training and facilitate psychoeducational groups.
- Provide input to case management plans with an emphasis on relapse prevention.
- Monitor the day-to-day operations and equipment of the residential facility to ensure quality control and cleanliness in compliance with licensing regulations.

QUALIFICATIONS:

- Diploma in Social Services/Substance Use from an accredited educational institution.
- Minimum of one (1) year experience facilitating substance use groups and providing individual support within a bed-based substance use program setting.
- Understanding of substance use and mental health.
- Experience working in a licensed facility would be an asset.
- Excellent professional communication skills, both written and verbal.
- Valid driver's license (Class 5) with satisfactory driving record.



MANDATORY JOB REQUIREMENTS:

- Food Safe Level 1.
- Standard First Aid with CPR-C.
- Evidence of COVID-19 vaccination status.
- Evidence of a Tuberculosis Test and compliance with the TB Control Program.
- Doctor's Note of fitness required.
- Satisfactory Criminal Record Review (Vulnerable Sector Search).
- This position requires union membership.
