**We are recruiting for a Full time, Youth Support Worker for A'mut Place.** Located in Surrey, [A'mut](#) is a full-time live-in program for adjudicated Indigenous female youth between the ages of 12-to-18 as an alternative to incarceration. Youth support workers manage the day to day living environment and provide culture-based programming that addresses substance use, wellness and mastering new skills for their futures. Staff are supported by an art facilitator, Elder, and community-based resources.

### **KEY RESPONSIBILITIES:**

- Ensure the safety and wellbeing of youth in the program.
- Act as a positive role model for clients, providing life skills training and behavior management.
- Support youth in achieving and maintaining their goals. Enable youth to address their substance use and personal risk factors.
- Record all activities and interactions with participants.
- Lead daily group activities and participate in case management.
- Maintain day-to-day operations of residence in adherence to Community Care regulations.

### **QUALIFICATIONS:**

- Diploma in related field plus two (2) years related experience or the equivalent combination of education and experience.
- Experience in bed-based environment with knowledge of issues related to substance use and trauma, or like and similar experience.
- Working knowledge of legislation and policies related to Social Assistance, Mental Health Act and Youth Justice.
- Understanding of the biopsychosocial spiritual model of substance-use, as well as trauma-informed practice.
- Experience working with Indigenous cultures and understanding of culturally safe practices.
- Excellent communication skills both written and verbal.
- Ability to lift up to 30 lbs.

**MANDATORY JOB REQUIREMENTS:**

- Food Safe Level 1.
- Standard First Aid with CPR-C.
- Evidence of COVID-19 vaccination status.
- Evidence of a Tuberculosis Test and compliance with the TB Control Program.
