We are recruiting a Part Time, Residential House Worker Cleaner for our Rosewood program. Located in Surrey, Rosewood is a 60-room shelter for women and their children. Women receive around the clock support to address their immediate crisis needs and to plan for long term housing facility.

KEY RESPONSIBILITIES:

- Responsible for dusting, sweeping, mopping, vacuuming, polishing surface floors.
- Maintains cleanliness of common areas (lobbies, elevators, walkways, entrance and exits, and among others).
- Spot clean walls, partitions, light switches, windows, and windowsills.
- Deep cleans and disinfects washroom facilities.
- Handles garbage & recycling collection.
- Operates cleaning janitorial equipment and other associated tools and cleaning materials.

QUALIFICATIONS:

- Previous janitorial experience in residential facility will be an asset.
- Building Maintenance Training Preferred.
- Knowledgeable with the British Columbia Occupational Health & Safety Regulation.
- Demonstrates satisfactory communication skills both written and verbal.
- Self-motivated individual who gets the job well done and ability to organize work.
- Ability to walk, bend, push, pull and lift repetitively throughout the shift.
- Knowledge of cleaning chemicals, proper storage and disposal is an asset.
- Ability to engage in positive and respectful working relationships with staff, colleagues, and tenants.
- A valid driver's license is an asset.
- Ability to lift up to 50 lbs.
